Invoices are sent monthly by email.

Your child is enrolled for the four months September through December. Tuition is equally divided into four payments. If withdrawing from classes, a written notice must be submitted before the 25th of the month prior to changes. If not you will continue to be charged.

Monthly tuition is due the first (1st) of every month.

A late fee of \$10.00 will be charged after the 8th day of the month. After 14 days a friendly reminder will be mailed home. If by the 20th of the month FADC is not notified or a payment plan is not mutually agreed upon, we will be unable to have your dancer(s) continue to take classes.

All tuition and fees are non-refundable.

We are asking every dancer to sell 25 raffle tickets. The dancer with the most tickets sold over 25 tickets will receive a \$50 credit on their next month's bill.



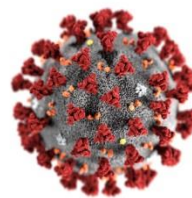
Raffle cost: \$5 for 1 ticket \$10 for 2 tickets and \$20 for 5 tickets (best deal)
