Invoices are sent monthly by email.

All students' accounts that keep a credit card on file and have it charged monthly will receive a \$5.00 discount per month.

Your child is enrolled for the nine month calendar year - August through May-excluding December. Tuition is equally divided into nine payments.

If withdrawing from classes, a written notice must be submitted before the 25th of the month prior to changes. If not you will continue to be charged.

Monthly tuition is due the first (1st) of every month.

A late fee of \$10.00 will be charged after the 7th day of the month. After 14 days a friendly reminder will be mailed home.

If by the 20<sup>th</sup> of the month FADC is not notified or a payment plan is not mutually agreed upon, we will be unable to have your dancer(s) continue to take classes.

All tuition and fees are non-refundable.

A late fee will be applied to late costume deposit fee and balance fees.
